1	The announcement is a bit confusing as it alludes to allowing non-native species monoculture, but update doesn't provide guidance on this. What is Verra's position on non-native species, monoculture, and invasive species? The invasive species content in the update was contradictory in places. Projects are only allowed to use non-native monocultures if they satisfy all safeguard requirements and other program and methodology requirements
2	Why has Verra weakened its environmental Safeguards guidance from what it announced in 4.5? Non-native species and monoculture are harmful (other than for already established IFM). It is not easy to contain harm. Invasive species are spread through gravity, wind, water, animals, etc. Allowing this would not be best practice. Why has Verra weakened its stance on environmental Safeguards? Environmental integrity and biodiversity are the flip side of climate change - not separate climate benefits. The size of the area dedicated for habitat connectivity is entirely dependent on the area and ecosystem(s) where the project is located, and specifically on whether the project has presence of rare, threatened, and/or endangered species.

With the new safeguards measures we'd like to be more clear on in farming the extent of stakeholder engagement that is expected on private land.	Anonymous Attendee	Thanks for the question. There are definitely cases where relevant stakeholders expand beyond the land owner or tenant, especially when it comes to ensuring the project causes no net harm. For instance, now that in the new version of the VCS standard we require to minimize the release of chemical pesticides and fertilizers, the release may go beyond the project boundary (farm in this case), so it is imperative that the project proponent maps all the relevant stakeholders, especially those that may be at risk from the implementation of project activities.

41	World Bank Safeguards which are considered best practice do not allow for use of WHO banned chemicals and pesticides. Some are also banned in host countries. Update allows for banned chemicals to be used as per its current wording as long as it is "minimized". Why is this guidance on this weaker than established best practices?	Anonymous Attendee	Verra also does not allow the use of banned chemical and pesticides, this is stated in VCS requirement "3.1.4 Projects and the implementation of project activities shall not lead to the violation of any applicable law, regardless of whether or not the law is enforced."
